Liability Waiver Notice

- I am not aware of any medical condition, including a psychological or psychiatric condition, that could affect my participation in the Trainings. If I have concerns about my state of health, I agree to consult a health care professional before participating in the Trainings or other programs and activities offered by Dolfino.
